**Articles of Incorporation
of
Sacramento Area Creeks Council
A California Public Benefit Corporation**

ONE: The name of this corporation is Sacramento Area Creeks Council.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are **to provide educational and charitable assistance to the general public by providing information, educational resources and stewardship opportunities that encourage the protection, restoration and maintenance of natural streams in Sacramento County.**

THREE: The name and address in the State of California of this corporation's initial agent for service of process is **Alta Tura 4855 Hamilton Street Sacramento CA 95841**

FOUR: (a) This corporation is organized and operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.
